## ALL BREED CHAMPIONS AND RESERVES MUST STAY FOR CHAMPIONSHIP SELECTION!

We will be selecting a TOP 5 during the Championship Drive. Any exhibitor who shows a Champion or Reserve Breed Steer or Heifer must stay for the Championship Drive selection in order to receive points and premiums at all sanctioned shows.

## HEIFERS/STEEERS PURCHASED AT THE 2021 IOWA BEEF EXPO SALES ARE ELIGIBLE FOR THE JR. SHOW

The only exception which will be made for entries received after Feb 1. for the junior show will be for show heifers and steers which are purchased in one of the sales held during the 2021 Expo. If you purchase a heifer or steer from one of the Expo Sales, and you desire to show it on Saturday or Sunday, you should report to the cattle barn office after the sale and enter the animal. The information is necessary in order to reserve stall space for you.

## Arrival Times for Junior Cattle

Because we will be Checking in ALL junior cattle on Friday Feb. 19, junior exhibitors may arrive beginning at 8 a.m. Thursday morning. We will start stalling immediately in both the Cattle Barn and Tie-Outs. Upon arrival on Thursday, all junior exhibitors MUST enter at the IJBBA Gate located on east University Avenue, look to the IJBBA website for a map. You will receive your unloading permit and stalling at the check-in trailer. If you have questions please reach out to any advisor ahead of time so we can address before there are any issues. No one will be allowed to unload without barn manager permission, those not complying are subject to disqualification from the show.

## DNA/Blood-Typing

All breed association's reserve the right to blood-type/DNA/retinal eye scan any cattle being shown within their breed divisions. Request for blood-type/DNA testing/retinal eye scan can come from the breed association or the IJBBA at any sanctioned show throughout the year beginning with the Iowa Beef Expo. Should testing reveal that the animal has been misrepresented on its registration papers, the exhibitor will be immediately withdrawn from the point program for the remainder of the year and any points previously earned will be void. This applies to both steers and heifers.

## Pop-up Fitting Tents

All pop-up fitting tents MUST be in the designated tent area. You must fill out your Tent Permit in the cattle barn office and make payment, the charge is \$1 per square foot and you will be refunded 50% of your rate once you have taken down your tent and cleaned up the area, and the barn manager has given approval. ## Rock Island Trailer Parking

Because of the large number of trailers, Rock Island will be PERMIT parking only starting Thursday, Feb 19 at 8 a.m. Again this year, trailer permits will be available for purchase HORSERACE STYLE CLOSING FORMAT online at [www.sconlinesale.com](http://www.sconlinesale.com) on Jan. 31. Classes will be offered for the following breeds only. Breeds not listed here must show in the crossbred/commercial divisions.

**Breeding Heifer Divisions:**

Aberdeen, Aberdeen Percentage, American Blue, Angus, Buelingo, Charolais Percentage, Charolais, Chianina, Gelbvieh, Gelbvieh Balancer, Horned Hereford, Polled Hereford, Limousin, Lim-Flex, High % Maine-Anjou, Mainetainer, Maine Angus, Miniature Hereford, Red Angus, Foundation Red Angus, Salers, Shorthorn Plus, Shorthorn, High % Simmental, Foundation Simmental, Simbrah, South Devon, Commercial.

**Market Animal Divisions:**

**Market Heifers**

Steer Breeds: Aberdeen, Aberdeen Percentage, American Blue, Angus, Buelingo, Charolais, Chianina, Gelbvieh, Hereford, Limousin, Maine-Anjou, Mainetainer, Maine Angus, Miniature Hereford, Red Angus, Salers, Shorthorn Plus, Shorthorn, Simmental, South Devon, Crossbred.

*All breeding heifers/market animals must be registered with their respective breed association and conform to their Iowa Breed Association rules for registration and exhibition.*

**Heifers:**

Breeding heifers must be born after 9-1-19. Commercial heifers will be shown by weight and classes will be divided into divisions. All heifers must be owned by the exhibitor. Heifers may only be shown in a breed show or as a crossbred.

**Market Animals:**

Must be born in 2020. Steers must be entered in the breed class of which they show a predominance of such breed characteristics. Please refer to classification of breed rules to enter steers in their correct breed. Steers will be classified by breed with uniform class breaks by weight. No re-weights. Steers that do not meet breed class guidelines will be put in the crossbred class. Crossbred steers and market heifers will be shown by weight and classes will be divided into divisions.

**General:**

Exhibitors must be present to show their own calf. Absolutely no substitute showmen will be allowed. No cattle will be shown by anyone except by the person's whose name the calf is entered in. The only exception is if an exhibitor has two or more animals in one class.

All exhibitors must be a paid member of the Iowa Jr. Beef Breeds Association. No out of state exhibitors, steers, or heifers are allowed. **BREED CLASS EXHIBITORS MUST ALSO BELONG TO THEIR RESPECTIVE IOWA JR. BREED ASSOCIATION IN WHICH THEY ARE EXHIBITING.** All steers and heifers that require registration papers must have papers at time of check-in. All registration papers must meet the requirements of their state breed association for junior exhibition.

**Protests:**

Site-specific protest must be filed at the IJBBA Sanctions Show. Any person wishing to have an animal inspected is required to submit a written protest and be accompanied by \$100. The person placing the protest is responsible for all costs incurred to verify the protest. Written protest must state plainly the cause of the complaint and must be filed before the championship drive at the sanctioned show. If inspection is not sustained, the protest money will be forfeited. Protests will be handled by the breed association involved, crossbred protest will be handled by the executive Director and the IJBBA Advisors.

**Championship Drive:**

All Grand and Reserve Grand Champion Breed or Division steers, market heifers and breeding heifers must stay and participate in the Top 5 Supreme Championship selection on Sunday afternoon in order to receive points or premiums.

**2021 BREED REQUIREMENTS**

**AMERICAN ABERDEEN:** All animals must be registered solely in the Junior Exhibitor's name, have readable tattoo's and registration papers in hand at check in. For more breed requirements contact Kevin Litchfield 515-432-8441. Breeding females must have 50% or greater American Aberdeen as their makeup. Steers must have 25% or greater of American Aberdeen as their makeup.

Fullblood - 100% American Aberdeen reg  
Percentage Female - 50% - 99.9%  
Percentage Steers - 25% - 99.9%

**AMERICAN BLUE CATTLE:** Steers and Heifers must be at least 50% or higher American Blue. Registration papers must be in hand at time of check-in and in the junior exhibitor's name only. All animals must have a readable tattoo. Juniors between the ages of 8 and 20 years of age as of January 1st of current year may show.

**ANGUS:** Steers and heifers must have registration papers in hand at time of check-in; no fax copies will be accepted. Papers must be in the junior exhibitor's name. All animals must have readable tattoos. All exhibitors must follow the rules of the American Angus Association. Juniors between the ages of 8 and 20 years of age as of January 1st of current year may show.

**BUELINGO:** Body color black or red with a clearly defined, continuous white belt. The belt to be of medium width, beginning behind the shoulder and extending nearly to the hips. Registration Papers Required

**CHAROLAIS:** Steers must be at least 50% or higher. The steer must have a certificate of recordation with the AICA and be 100% owned by the junior and in the exhibitor's name only. Purebred heifers registration papers must be 100% owned by the junior and in the exhibitor's name only.

**CHAROLAIS PERCENTAGE HEIFER:** Percentage heifers must be composed of at least 50% and no more than 15/16 Charolais. Heifers must have a certificate of recordation with the AICA and it must be 100% owned by the junior and in the junior exhibitor's name only.

**CHIANINA:** All percentages of Chiangus, Chianina, Chimaine, Chiford and CAX (steers & heifers) that are able to be registered are eligible. They must be registered in the exhibitors name and have papers/digital copy in hand at check-in.

**GELBIEH:** Steers must be 50% Gelbvieh or more and exhibitor must have an official Gelbvieh breeder affidavit. Affidavits may be obtained from the American Gelbvieh Association website [www.gelbvieh.org](http://www.gelbvieh.org) or contacting the AGA at 303-465-BEEF. Females must be registered and at least 75% Gelbvieh. Registration papers need to be in the exhibitor's name.

**GELBIEH BALANCERS:** Are 25% to 75% Gelbvieh with the balance Angus or Red Angus. Registration papers need to be in the exhibitor's name.

**HEREFORDS:** PLEASE make sure you check your registration papers for entries in Polled or Horned Division.

**POLLED HEREFORDS:** We are one association, but will have two separate heifer shows, steers will be shown polled & horned as one division. Heifers must have registration papers. Steers must have registration papers, no certificates will be accepted. Animals may be co-owned with siblings, provided each junior owner is an individual National Junior Hereford member and a member of the Iowa Junior Hereford Association for the year 2020. All exhibitors must follow the rules of the American Junior Hereford Association.

**HORNED HEREFORDS:** We are one association, but will have two separate heifer shows, steers will be shown polled & horned as one division. Heifers must have registration papers. Steers must have registration papers, no certificates will be accepted. Animals may be co-owned with siblings, provided each junior owner is an individual National Junior Hereford member and a member of the Iowa Junior Hereford Association for the year 2020. All exhibitors must follow the rules of the American Junior Hereford Association.

**LIMOUSIN:** Steers must be 37.5% or higher NALF Limousin blood and have registration papers. Heifers must be 75% or greater Limousin blood and have an orange NALF registration paper. Must have registration papers in hand at check-in and be in the exhibitor's name.

**LIM-FLEX FEMALES:** Females registered as Lim-Flex with a purple NALF registration certificate will be eligible to compete. 75% Lim-Flex females are not eligible for the Limousin female show. Must have registration papers in hand at check-in and be in the exhibitor's name.

**MAINE-ANJOU:** MaineTainer heifers will include 1/4 to 5/8 Maine Anjou females and have a GREEN registration paper. High Percentage heifers will include 75% and above females and have a BROWN registration paper. Maine-Angus heifers will have between 3/8 Maine-Anjou to 5/8 Maine-Anjou blood and have between 3/8 registered Angus to 5/8 registered Angus and/or registered Red Angus blood. All Maine-Angus females must be TH and PHA Free by either parents or test and have an AMAA-issued Maine-Angus BLUE registration paper. All qualifying individuals WILL BE predominately solid black or red in color. White Markings are ONLY allowed on the underline and switch of the tail. Maine-Angus CANNOT show as MaineTainer. Steers must be at least 1/4 blood Maine-Anjou, all steers will show as Maine Anjou steers. If heifers are purchased at the Iowa Beef Expo and desire to show in the junior show, they must have been purchased through the Maine-Anjou sale. All exhibitors must have original registration papers OR digital registration papers (not a copy of the pedigree) in hand at time of check-in and papers need to be solely in the junior exhibitor's name. All animals must have legible and correct tattoos. Exhibitor's must be a member of the Iowa Junior Maine-Anjou Association and pay a \$10.00 annual fee. All exhibitors must follow the rules of the American Junior Maine-Anjou Association.

**MINIATURE HEREFORD (POLLED & HORNED):** Miniature Herefords will show both polled and horned heifers together and polled and horned steers together. Heifers & Steers must have registration in hand at time of check-in, they must be registered by the American Hereford Association (AHA) and be out of an AHA registered sire and dam. Animals may be co-owned with siblings, or within the family farm name. If the animal is in the family farm name it must be proven that the junior exhibitor is either a son or daughter of owners of the family farm. Heifers and steers will be measured, and Heifers may be no greater than 45" tall at the hip and steers may be no greater than 48" at the hip. PLEASE make sure you check your registration papers and height requirements. Questions, contact Brent White at 641.777.8821.

**RED ANGUS:** Steers must be 50% or more Red Angus from one registered parent, be predominately red in color and display sufficient breed characteristics, which match % of registration. Heifers must be 87% or higher Red Angus. Steer & Heifer exhibitors must have registration papers from the National Red Angus Association, must be in hand AND in the exhibitors name. Exhibitor must be a paid member in the Iowa Junior Red Angus Association.

**FOUNDATION RED ANGUS HEIFER DIVISION:** Must be between 50 and 86% Red Angus and from one registered parent, be predominately red in color and display sufficient breed characteristics. Must have registration papers from the National Red Angus Association, must be in hand AND in the exhibitors name. Exhibitor must be a paid member in the Iowa Junior Red Angus Association.

**SALERS:** Animals must be 50% or more Salers with either the dam or sire being registered. Both steers and heifers must have registration papers and the papers must be in the name of the junior exhibitor.

**SHORTHORN:** Heifers and Steers must be at least 15/16 and must be registered solely in the junior exhibitor's name.

**SHORTHORN PLUS:** Heifers and Steers must be between 1/2 and 7/8 Shorthorn and must have appendix registration papers solely in the junior exhibitor's name.

**SIMMENTAL:** Purebred heifers 7/8 and above. Foundation heifers at least 1/2 but not yet reaching 7/8. Steers at least 1/2 blood or higher. Registration paper must be in hand or viewed on exhibitor's digital device from American Simmental Association's (ASA) Herdbook website. Animal must be registered in the junior's name, immediate family member, or family farm name that the junior is an authorized member of on the ASA account. Animals may be DNA tested at any time throughout the year to verify parentage. Parentage DNA must be on file with American Simmental Association for animals to be verified as meeting minimum % Simmental for the division in which they are being shown.

**SIMBRAH FEMALES:** 5/8 SM - 3/8 BR and must have registration paper in hand. Registration paper must be in hand and in the junior's name, immediate family, or family farm name that the junior is an authorized member of. All year-end award winners may be DNA parentage verified at any time.

**SOUTH DEVON:** Heifers and Steers must be 1/4 or higher and have registration papers. Animals do not need to be out of a South Devon sire. Papers must be in hand at check-in. Registration papers must be in the exhibitor's name.

# Show Rules

1. The Iowa Junior Beef Breeds Association (IJBBA) will be giving an award to members who accumulate the greatest number of points in a given year in each breed. Breed classes and year-end awards will only be offered to those breeds, which are paid members of the Iowa Beef Breeds Council (IBBC). A show year will run from Winter Expo to the first Monday of August.

2. In order to earn points, exhibitors must be a paid member of the Iowa Junior Beef Breeds Association and each breed association in which they are exhibiting. All Breeding Heifers/Market Animals must be registered with their respective breed association and conform to their Iowa Breed Association rules for registration and exhibition. Points will not be accumulated prior to the date membership dues are paid or postmarked within 7 days of the show.

3. Exhibitors must meet the age requirements of their respective Junior Breed Associations. I.J.B.B.A. members cannot have reached their 21st birthday prior to January 1, 2021. Note: exhibitor must be 20 as of January 1, 2021.

4. The Iowa Junior Beef Breeds Association (IJBBA) will be giving an award to the Supreme Breeding Heifer Exhibitor and Supreme Market Animal Exhibitor. This will be based on the number of Supreme titles an exhibitor accumulates through the show season. Supreme titles will NOT be counted if the exhibitor does not show their own animal. In case of a tie, the number of Reserve Supreme titles will determine the winner.

5. IJBBA members must exhibit at six shows to receive the year-end awards presented by IJBBA.

6. Points shall be earned on the following basis:

Classes must have no more than 15 head per class.

The I.J.B.B.A. reserves the right to correct point standings at any time during the year.

7. All IJBBA sanctioned shows must select champions and reserves for each breed, as well as a Top 5 for Supreme Champion Market Animal and Supreme Champion Breeding Heifer.

Points for these animals will be awarded as follows:

A. Supreme Champion will earn 30 points, and their class points will be replaced with the 1st place points of the largest class of the day.

B. Reserve Supreme will earn 25 points, and their class points will be replaced with the 1st place points of the largest class of the day.

C. 3rd Overall will earn 22 points, and their class points will be replaced with the 1st place points of the largest class of the day.

D. 4th Overall will earn 20 points, and their class points will be replaced with the 1st place points of the largest class of the day.

E. 5th Overall will earn 18 points, and their class points will be replaced with the 1st place points of the largest class of the day.

F. All other Breed Champions will earn 5 points, and their class points will be replaced with the 1st place points of the largest class within their breed.

G. All other Breed Reserves will earn 3 points, and their class points will be replaced with the 1st place points of the largest class within their breed.

8. All points recorded in a class are based on the actual number of cattle that enter the show ring for that particular class.

9. Shows may allow open class exhibitors who have not reached their 21st birthday as of January 1, 2021, but the open class exhibitors' points will be void and IJBBA members' points will not be realigned.

10. At a show, if one person exhibits a large number of cattle, only their three highest-point-earning breeding heifers/market animals from that day will be counted for his/her top ten points. However, all of their animals will receive points within their respective breed divisions for that day.

11. Sanctioned shows must offer breed/commercial/crossbred classes for steers and heifers regardless of the number entered.

12. Exhibitors must be present to show their own calf. In order for any points to be awarded, the cattle must be owned by, entered in the name of, and shown by the individual IJBBA member, exception being if the exhibitor has two or more animals in the same class.

**INJURY EXCEPTION:** The exception for a substitute showman will be approved by IJBBA Advisors in person or via phone. To be applicable for a substitute showman the injury must have occurred in the show ring or makeup arena of an IJBBA sanctioned show. The injury must be at the IJBBA Advisor's discretion. With extending injuries, a doctors' note must be presented stating that the exhibitor is unable to exhibit their animals at the future shows. Extending injuries that occur at an IJBBA show will allow for a substitute showman to show that animal for a 14-day time frame from date of injury. Extending injury consist of broken bones, torn ligaments that do not allow an IJBBA showman to show. Illness such as a sickness or vomiting will not be susceptible to a substitute showman, the only exception to illness is one that puts you in the hospital while at the event.

13. IJBBA sanctioned shows must offer Market Heifer shows. A Champion and Reserve Champion High Point Market Heifer Award will be given at year-end. All IJBBA sanctioned shows must allow the Champion Market Heifer to compete against the steers for a Supreme Market Animal of the show. Year-end over all top ten-market animals will be selected from both Market Steers and Market Heifer exhibitors.

14. IJBBA sanctioned shows must offer one showmanship contest with 2 divisions: Junior (13 years and younger) and Senior (14 years or older) as of January 1st. Each age division will include both breeding and market exhibitors. The top 2 high point showmanship exhibitors will receive awards at the year-end-awards ceremony. The champion of each division will receive 15 points plus their 5 participation points and the reserve of each division will receive 10 points plus their 5 participation points. All other participants will receive 5 participation points.

15. If an animal is disruptive to its class, it is at the discretion of the show management to dismiss it from that class. If the animal is dismissed during a championship class, the exhibitor will be disqualified and will lose only the points acquired in the championship class. The reserve animal will then move up to compete for champion, and no other animal will replace the reserve.

16. Breeding Heifers must be born after 9-1-19. Market Animals must be born in 2020.

17. If there are 3 or more head in a breed division, there is to be no more than 60 day age difference between cattle. (ex. January/February Class; March/April Class).

18. Use of hemp hair, removed hair, or other hair-like materials added to the animal's body will not be allowed. IJBBA does not allow surgical or any other alterations to the animals such as the use of permanent dyes or paints to alter the animals original color pattern. Exhibitors found in violation of this rule will be stripped of all their points and premiums for that day and all animals will be disqualified from the remainder of the show. After their third offense, it will be considered a code of conduct violation and will be handled accordingly.

19. Exhibitors are not allowed to "fill" animals by using any artificial means of drenching such as pumps or bottles. Exhibitors found in violation of this rule will be stripped of all their points and premiums for that day and all animals will be disqualified from the remainder of the show. After their

third offense, it will be considered a code of conduct violation and will be handled accordingly.

20. All breed association's reserve the right to blood-type/DNA/retinal eye scan any cattle being shown within their breed divisions. Request for blood-type/DNA testing/retinal eye scan can come from the breed association or the IJBBA at any sanctioned show throughout the year beginning with the Iowa Beef Expo. Should testing reveal that the animal has been misrepresented on its registration papers, the exhibitor will be immediately withdrawn from the point program within that respective breed for the remainder of the year and any points previously earned in that breed division will be void due to the fact that individual animals are not tracked. This applies both to steers and heifers.

21. At Breed Field Days, exhibitors will receive points only for their breed and class placings. They will not receive any Top 5 (aka "Supreme") points, and they will not be considered for the Supreme Exhibitor competition.

\* At Field Days where animals are only allowed to show as "Owned" OR "Bred & Owned" (not both), the divisions will be considered as separate shows for the purpose of points.

\* At Field Days where animals may be shown in BOTH "Owned" AND "Bred & Owned" divisions, exhibitors will receive the highest points earned for each animal (regardless of which show they competed in). Animals will NOT receive points for BOTH "Owned" AND "Bred & Owned" shows, only the points for each animal which were highest.

22. Site-specific protests must be filed at the IJBBA Sanctioned Show. Any person wishing to have an animal inspected is required to submit a written protest and be accompanied by \$100.00. The person placing the protest is responsible for all costs incurred to verify the protest. Written protest must state plainly the cause of the complaint and must be filed before the championship drive at the sanctioned show. If inspection is

not sustained, the protest money will be forfeited. Protests will be handled by the breed association involved, crossbred protests will be handled by the Executive Director and the IJBBA Advisors.

23. Conduct: Any unsportsmanlike conduct or misrepresentation on the part of an IJBBA member will not be tolerated. All IJBBA members and family/guardians are expected to be cooperative and courteous at all times. Any IJBBA member or family/guardian not complying with this rule is subject to disqualification or any other steps deemed desirable.

24. Dress Code: At a minimum all IJBBA members must exhibit in a collared neck shirt with sleeves/short sleeves and the shirt must remain tucked in at all times during exhibition. Any IJBBA member not complying with the dress code at an IJBBA Sanctioned Show will not receive points for that show.

25. If a sanctioned IJBBA show receives a bad check for an entry fee, IJBBA requests that show management contact the exhibitor and give them 10 days to submit a cashier's check/money order or cash to their show for reimbursement of their entry fee. Show management must also notify Malloory Robinson immediately. This exhibitor will automatically forfeit that day's show points. If after one bad check has been written and not cleared by the exhibitor, this exhibitor will not be allowed to participate in any other IJBBA sanctioned shows for the remainder of the year. If an exhibitor writes 3 or more bad checks during the 2020 show season, whether they make good on them or not, the exhibitor will be stripped of all points accumulated for the year along with their IJBBA membership for 2020.

26. Sanctioned shows are required to submit a \$150.00 deposit to the IJBBA upon sanctioning. \$50 of this deposit will be refunded if the show turns in their show results within one week (7 days) of the show's completion. \$50 will be refunded if the show results are submitted on the official Excel Show Results Template from the IJBBA. If results are not turned in within 7 days the show will not be sanctioned the following year.



# Iowa Junior Beef Breeds Association Scholarship *Application Requirements*

There is NO formal application.

## SCHOLARSHIP ELIGIBILITY

- Must be an Iowa resident.
- The applicant for the scholarship for 2021 high school seniors must be a current member of the Iowa Junior Beef Breeds Association (IJBBA).
- The applicant for the scholarship for current college students must either be a current member of the IJBBA or a former member of the IJBBA.
- Contestants are not limited to attending a four-year college - vocational schools, trade schools and community colleges are also acceptable.

## AMOUNT OF SCHOLARSHIPS

- Two scholarships will be awarded for high school seniors graduating in 2021. It will consist of one \$750 and one \$500 per year for two consecutive years that the student remains in school with a maximum of \$1500 and \$1000 total. Should the student drop from school, the scholarship is permanently terminated. If, for example, the winner attended the American Institute of Business on that institution's 20 month program, the individual would receive a maximum of \$750 or \$500 unless after completing that program, they would immediately transfer to another school that would accept the credits they had already earned. In that case, the maximum scholarship amount would then apply.
- Two scholarships will be awarded to students who have completed either one or two years at a four-year college or university, vocational school, trade school, or community college. It will consist of one \$750 and one \$500 per year for two consecutive years that the student remains in school with a maximum of \$1500 and \$1000 total. Should the student drop from school, the scholarship is permanently terminated. As explained under item A. above it is acceptable for the student to transfer to another school during the effective period of the scholarship. Scholarship recipients will receive scholarship checks AFTER THE FALL SEMESTER, usually in late December or early January. Evidence of passing grades and proof of re-enrollment at their school must be provided.

PAST WINNERS OF THE HIGH SCHOOL IJBBA SCHOLARSHIP ARE NOT ELIGIBLE FOR THIS SCHOLARSHIP.

## SELECTION OF WINNERS

- All applications will be forwarded to the IBBC Scholarship committee.
- All applicants will be interviewed for final consideration for their respective scholarship.
- The final winner of each scholarship will be selected by outside judges. A minimum of two qualified judges will be used who are accustomed to dealing with scholarship applications.

## CRITERIA USED FOR SELECTION

Criteria to be used by the Judges in their selection of the 2021 High School Senior Scholarships and Post High School Student Scholarships:

There is NO Formal Application!  
Applicants must present the information requested in an original and self-made format.

- Neatness of Application please be sure to include your name, address, phone, cell phone and email - 5 POINTS.
  - Use of language
  - Spelling
  - Punctuation
- Personal interview. The ability of the applicant to sell themselves - 20 POINTS.
- Scholarship. A transcript of the applicant's high school or university, vocational, or trade school grades - 10 POINTS.
- Past accomplishments with cattle - 10 POINTS
- Leadership accomplishments - 10 POINTS
- Initiative and participation. The ability to start, stay with and finish a project. This should include extra-curricular activities at current school. In the case of post high school applicants, credit will be given to students employed to assist with school expenses. - 25 POINTS
- A typed essay of up to 500 words on "I feel an important issue facing the cattle industry is \_\_?\_\_. It is important because \_\_?\_\_." -20 POINTS
